We will be taking a vote on proposed changes to the Standing Rules at the February meeting. All of the proposals EXCEPT the one on Security and Privacy will be proposed by acclamation. That means no additional reading and voted on all at once. Anyone who wants an item pulled from the acclamation vote can make a motion to do that. Separate votes will be taken on any of those items members moved to have removed from the acclamation vote.



#### Changes to the Changes of Proposed Standing Rule for Privacy and Security

Based on the information and concerns shared during our discussion of proposed Changes to Standing Rules I am sharing the original proposal and a modification of the proposal. Below you will find both the original and the new proposal.

At our February meeting the Privacy and Security time will NOT be part of the vote by acclamation. Both the original proposal and the new proposals will be read and discussed. There will be a separate vote on the item. Members will have the option to:

- Vote yes or no on the original proposal.
- Vote yes or no on new proposal #2.
- Vote yes or no on new proposal #3
- Vote no on all and make no changes
  - No change would mean we <u>all must use the BCC option.</u>
  - There is no requirement to explain how to use the option.
  - Each member would be required to individually input all the email addresses with no way of knowing if the information is consistent.
  - Small committees would be required to use the BCC option.

#### **Privacy and Security**

**<u>2. Now Reads</u>**: Any SGVD member sending an email to all members or a group of members shall be requested to use the BCC option.

#### **Option 1 Discussed at January 13, 2023 Birthday Council**

**Proposed Change:** Any SGVD member sending a mass an-email defined as any email message sent to the entire group or large subset for the purpose of sending general information such as an announcement of an event that does not ask for/need a response and a majority of people being emailing don't know each other to members or a group of members shall be requested to use the BCC option. When a message is sent to a group of members that may require a response the BCC option will NOT be used unless requested by individual member(s). Those who are Bcc'd are expected to not respond since the other party doesn't know they were included or were

privy to the conversation. The use of Bcc shall be included as a notice to those receiving the email.

**<u>Rationale:</u>** Several members are concerned about the inclusion of their email address in messages sent to members. They want to protect themselves against receiving unnecessary replies, viruses and spam. They would like all emailed communication from the District to use the Bcc format. Others are concerned that using the Bcc option is a sneaky or underhanded way to create a paper trail and is a violation of trust. They want to be sure that their replies to any message are only sent to people whose names are listed as recipients to the message. A Standing Rules needs to balance the concerns members.

**If Amended would Read:** 2. Any SGVD member sending *a mass* email *defined as* **any email message sent to the entire group or large subset** for the purpose of sending general information such as an announcement of an event that does not ask for/need a response and a majority of people being emailing don't know each other, shall be requested to use the Bcc option. When a message is sent to a group of members that may require a response the Bcc option will NOT be used unless requested by individual member(s). <u>Those who are Bcc'd are expected to not respond since the other party doesn't know they were included or were privy to the conversation</u>. The use of Bcc shall be included as a notice to those receiving the email.

#### **Option 2 Based on Input after January 13, 2023 Birthday Council**

**<u>2. Now Reads</u>**: Any SGVD member sending an email to all members or a group of members shall be requested to use the BCC option.

**Proposed Change:** Any SGVD member sending an email to all members or a group of members shall be requested to use the BCC option. An explanation of how to use the BCC option and how using this option changes the manner in which responses are received will be placed in the San Gabriel Valley Yearbook. Officers and Committee Chairpersons who will need to use the BCC option will be provided a confidential email "To Line" of addresses from the newsletter chairperson. Each time the email "To Line" is updated that will be sent Officers and Committee Chairpersons who will need to use the BCC option. Small committees may decide as a group to not use the BCC option for any committee members who are agreeable to this decision. Rationale: Members shared that many did not know how to use the BCC option and were not aware that when using this option responses only go to the originator of the email message. When someone does not know how to do something they generally won't do it. That is way an explanation would be included in the yearbook. Creating an email "To Line" for our large organization is a time consuming and detailed task. If everyone sending a message creates their own "To Line", there is no guarantee as to the accuracy of address information. Consistency is important for quality communication. Having one source of the address information that is easily usable will facilitate a more efficient use of the BCC option. Smaller committee often use email as a way to discuss pending issues and arrange potential dates for meetings. The change would allow this practice of using email as a discussion and scheduling tool to continue and give the option to any committee member to only be communicated with using the BCC option.

**If Amended would Read:** Any SGVD member sending an email to all members or a group of members shall be requested to use the BCC option. *An explanation of how to use the BCC option and how using this option changes the manner in which responses are received will be placed in the San Gabriel Valley Yearbook. Officers and Committee Chairpersons who will need to use* 

the BCC option will be provided a confidential email "To Line" of addresses from the newsletter chairperson. Each time the email "To Line" is updated that will be sent Officers and Committee Chairpersons who will need to use the BCC option. Small committees may decide as a group to not use the BCC option for any committee members who are agreeable to this decision.

## **Option 3 Based on Input after January 13, 2023 Birthday Council**

2. Now Reads: Any SGVD member sending an email to all members or a group of members shall be requested to use the BCC option.

**Proposed Change:** Any SGVD member sending an email to all members or a group of members shall be requested to use the BCC option. An explanation of how to use the BCC option and how using this option changes the manner in which responses are received will be placed in the San Gabriel Valley Yearbook. Officers and Committee Chairpersons who will need to use the BCC option will be provided a confidential email "To Line" of addresses from the newsletter chairperson. # San Gabriel Valley District of Women's Clubs **Proposed Bylaw Changes for 2023**

#### **Article VI – Officers and their Duties**

**Propose adding new Section 11:** The president at their discretion may appoint an historian, a librarian, a curator, a chaplain, a sergeant-at-arms and/or a doorkeeper.

Rationale: Presidents may need help in a variety of areas. All of the proposed options come from suggestions in Robert's Rules 47:40.

If amended Section 11 shall read: The president at their discretion may appoint an historian, a librarian, a curator, a chaplain, a sergeant-at-arms and/or a doorkeeper.

#### **ARTICLE VII – Executive Board**

Section 9 Now Reads: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, at the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be

conducted electronically. The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other. The notice of the electronic meeting must include adequate description of how to participate in it.

**Proposed Section 9:** In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other. The notice of the electronic meeting must include adequate description of how to participate in it.

**<u>Rationale:</u>** Our experience with the use of electronic meetings has demonstrated that many meetings can be successfully conducted electronically and that this option often allows for more members to be able to participate in meetings.

**If Amended Section 9 Would Read:** In the event of national, state or local emergencies, manmade or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. The notice of the electronic meeting must include adequate description of how to participate in it.

## **ARTICLE VIII – Executive Committee**

Section 10 Now Reads: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, at the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other. The notice of the electronic meeting must include adequate description of how to participate in it.

**Proposed Section 10:** In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other. The notice of the electronic meeting must include adequate description of how to participate in it.

**<u>Rationale:</u>** Our experience with the use of electronic meetings has demonstrated that many meetings can be successfully conducted electronically and that this option often allows for more members to be able to participate in meetings.

**If Amended Section 10 Would Read:** In the event of national, state or local emergencies, manmade or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee,-the Executive Committee and/or Executive Board meetings may be conducted electronically. The notice of the electronic meeting must include adequate description of how to participate in it.

#### Article XI – Annual Meeting/Convention

<u>Section 5 Now Reads</u>: A delegate shall represent but one (1) Club and shall have one (1) vote. Voting proxy, either written or verbal, shall not be permitted. A Club President who attends a

convention, including the Federated/Affiliate Groups, who holds a District/SGVD, State or General Federation Office or Chairpersonship, or is a Past District/SGVD President of San Gabriel Valley District/SGVD, shall represent her Club as a delegate to convention and the Spring Council in an election year.

**Proposed Changes:** A delegate shall represent but one (1) Club and shall have one (1) vote. Voting proxy, either written or verbal, shall not be permitted. A Club President An Executive Board Member who attends a convention, including the Federated/Affiliate Groups, who holds a District/SGVD, State or General Federation Office or Chairpersonship, or is a Past District/SGVD President of San Gabriel Valley District/SGVD, shall represent her Club represent their highest position as a delegate to convention and the Spring Council in an election year. Should they also have a vote as an officer or delegate from their Club, the Club shall assign an alternate delegate.

**Rationale:** The new language accurately describes the delegate/voting practices that have been followed by the District for the past many years. If the currently Bylaw language was in fact used, there would be a voting penalty for any Club with a voting delegate that also was a member of the SGVD Executive Board, a State or General Federation Officer or Chairpersonship, a past District/SGVD President or an Federated/Affiliate Group President. In addition to the new language being the accurate representation of the District's past practice, it is the same delegate/voting structure used by the CFWC.

**If Amended Section 5 Will Read:** A delegate shall represent but one (1) Club and shall have one (1) vote. Voting proxy, either written or verbal, shall not be permitted. An Executive Board Member who attends a convention, including the Federated/Affiliate Groups, who holds a District/SGVD, State or General Federation Office or Chairpersonship, or is a Past District/SGVD President of San Gabriel Valley District/SGVD, shall represent their highest position as a delegate to convention and the Spring Council in an election year. Should they also have a vote as an officer or delegate from their Club, the Club shall assign an alternate delegate.

#### Article XII – Nominations

Section 2 now reads: At Fall Executive Board or Council meeting prior to the annual meeting in an election year, the Executive Board shall elect an Election Board of five members and two alternates, none of whom shall be members of the Executive Board, and a Nominating Committee of five members and two alternates all of whom shall be members of the Executive Board. Alternates to both the Nominating Committee and the Election Board shall participate as observers at all meetings and step in as official active members as needed. The Election Board and Nominating Committee shall not have a majority of members from a single club.

**<u>Proposed Addition to Section 2:</u>** *Members of the Nominating Committee of the San Gabriel Valley District of Women's Clubs/SGVD cannot serve two consecutive terms.* 

#### **<u>Rationale</u>**: To support a fair and open nominating process.

<u>If amended Section 2 will then read</u>: At Fall Executive Board or Council meeting prior to the annual meeting in an election year, the Executive Board shall elect an Election Board of five

members and two alternates, none of whom shall be members of the Executive Board, and a Nominating Committee of five members and two alternates all of whom shall be members of the Executive Board. Alternates to both the Nominating Committee and the Election Board shall participate as observers at all meetings and step in as official active members as needed. The Election Board and Nominating Committee shall not have a majority of members from a single club. Members of the Nominating Committee of the San Gabriel Valley District of Women's Clubs/SGVD cannot serve two consecutive terms.

#### **Article XII – Nominations**

<u>Section 7 Now Reads</u>: Nominations from the floor at Spring Council shall be limited to nominees qualifying under the sections listed in these bylaws.

**Proposed Section 7:** Nominations from the floor for any elected position on the Executive Committee of the San Gabriel Valley District of Women's Clubs/SGVD shall be limited to nominees qualifying under the sections listed in these bylaws. Nominations from the floor may be made at any official meeting of the San Gabriel Valley District of Women's Clubs/SGVD after the slate of candidates is presented to the Executive Board by the Chairman of the Nominating Committee.

**Rationale:** Roberts Rules 46:18 states that the Chair must call for nominations from the floor at the session at which the elections takes place. It also states that nominations from the floor may be made after the Nominating Committee has presented its proposed slate and before the election. Many organizations allow this flexibility to increase member input into the nominating process. This will also make it easier for the names of those nominated from the floor to be printed on the ballot.

**If amended will then read:** Nominations from the floor for any elected position on the Executive Committee of the San Gabriel Valley District of Women's Clubs/SGVD shall be limited to nominees qualifying under the sections listed in these bylaws. Nominations from the floor may be made at any official meeting of the San Gabriel Valley District of Women's Clubs/SGVD after the slate of candidates is presented to the Executive Board by the Chairman of the Nominating Committee.

#### **Article XII – Nominations**

**Proposed Section 8:** *Members of the San Gabriel Valley of Women's Clubs/SGVD submitting their name for nomination, selected by the Nominating Committee for nomination and/or nominated from the floor for a financial position be required to include in the documents they submit examples of their job experience or financial education prior to being placed on the ballot. Should a financial officer be required to be bonded, they must meet the qualifications of the bonding agency prior to being allowed to fill the position.* 

**<u>Rationale:</u>** The San Gabriel Valley District of Women's Clubs (SGVD) engages in a significant amount of fund raising which requires the officers responsible for the finances to have appropriate skills, abilities and experiences.

**If amended will then read:** Members of the San Gabriel Valley of Women's Clubs/SGVD submitting their name for nomination, selected by the Nominating Committee for nomination and/or nominated from the floor for a financial position be required to include in the documents they submit examples of their job experience or financial education prior to being placed on the ballot. Should a financial officer be required to be bonded, they must meet the qualifications of the bonding agency prior to being allowed to fill the position.

## Article XIII – Elections

**Proposed new add Section 5 and renumber as needed:** The names of all members nominated by the Nominating Committee or nominated from the floor for a San Gabriel Valley District (SGVD) office shall have their names printed on the ballot prior to distribution of the ballots and prior to the start of voting. A place for the name of a write in candidate for each office shall appear on the ballot.

**Rationale:** This change will allow all members who are nominated to be treated equally and provided an equal opportunity to be elected. It also allows the SGVD to conform to the procedures of the General Federation of Women's Clubs (GFWC) -- California Federation of Women's (CFWC). Also, Roberts Rules 46:18 states "on a ballot vote in an election or other voting involving multiple possible choices, members are able to write in or fill in a vote for any eligible person or choice and are not confined to voting for or against candidates that appear on the ballot."

**If amended will then read:** The names of all members nominated by the Nominating Committee or nominated from the floor for a San Gabriel Valley District (SGVD) office shall have their names printed on the ballot prior to distribution of the ballots and prior to the start of voting. A place for the name of a write in candidate for each office shall appear on the ballot.

#### Article XIII – Elections

**Proposed adding Section 7:** The order of the names of candidates that are printed on the ballot will be determined by a chance drawing. The drawing shall be witnessed and certified by the members of the Nominating Committee.

**<u>Rationale</u>**: Voters who do not have a preference typically vote for the first name on a ballot. Roberts Rules suggests that to avoid position bias the order of the names on a ballot should be determined by a random process. **If amended will then read:** The order of the names of candidates that are printed on the ballot will be determined by a chance drawing. The drawing shall be witnessed and certified by the members of the Nominating Committee.

## Article XIII – Elections

**Proposed adding Section 8:** All members seeking an elected office in the San Gabriel Valley District of Women's Clubs/SGVD will be given an opportunity to give a two (2) minute speech on their qualifications to members of the Executive Board the meeting prior to the election.

**<u>Rationale</u>**: To ensure delegates have an opportunity to learn about the candidate prior to the election in order to make a more informed decision. To ensure candidates have an opportunity to tell members about their qualifications before a vote is taken.

**If amended will then read:** All members seeking an elected office in the San Gabriel Valley District of Women's Clubs/SGVD will be given an opportunity to give a two (2) minute speech on their qualifications to members of the Executive Board the meeting prior to the election.

## Article XIII – Elections

**Proposed adding Section 9**: All members seeking an elected office in the San Gabriel Valley District of Women's Clubs/SGVD be required to provide to the Nominating Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women's Clubs/GFWC - California Federation of Women's Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words. The Nominating Committee shall create a document containing all of the Candidate Statements and email them to all delegates no later than one (1) week prior to the election.

**<u>Rationale</u>**: To ensure delegates have an opportunity to learn about the candidate prior to the election in order to make a more informed decision.

**If amended will then read:** All members seeking an elected office in the San Gabriel Valley District of Women's Clubs/SGVD be required to provide to the Nominating Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women's Clubs/GFWC - California Federation of Women's Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words. The Nominating Committee shall create a document containing all of the Candidate Statements and email them to all delegates no later than one (1) week prior to the election.

**Article XIII – Elections** <u>Proposed adding Section 12</u>: Any candidate that is nominated from the floor on the day of the Election will have the opportunity to give a two (2) minute speech on their qualifications and provide their candidate statement to delegates at the meeting at which they are nominated.

**<u>Rationale</u>**: To ensure delegates have an opportunity to learn about the candidate prior to the election in order to make a more informed decision.

**If amended will then read:** Any candidate that is nominated from the floor on the day of the Election will have the opportunity to give a two (2) minute speech on their qualifications and provide their candidate statement to delegates at the meeting at which they are nominated.

# Article XV- State Endorsements

**Proposed added Section 2 and renumbering sections as needed.** Members of the San Gabriel Valley District requesting the Executive Committee consider endorsing a member including themselves for a CFWC or GFWC position shall submit to the Executive Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women's Clubs/GFWC - California Federation of Women's Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words.

**<u>Rationale</u>**: To ensure Executive Committee members have an opportunity to learn about the candidate prior to the Committee's approval of writing a letter of endorsement.

**If amended will then read:** Members of the San Gabriel Valley District requesting the Executive Committee consider endorsing a member including themselves for a CFWC or GFWC position shall submit to the Executive Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women's Clubs/GFWC - California Federation of Women's Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words.

**Proposed added Section 3 and renumbering sections as needed.** After the Executive Committee has completed the process for approving the writing of a letter of endorsement for a CFWC or GFWC position, if an additional person(s) make a request for a letter of endorsement at an Executive Board meeting, all potential members to be endorsed will have the opportunity to give a 2-minute speech prior to any vote being taken by the Board to approve the submission of a letter of endorsement on behalf of the SGVD.

**<u>Rationale</u>**: To ensure voting delegate have an opportunity to learn about the candidate prior to the Committee's approval of writing a letter of endorsement.

**If amended will read:** After the Executive Committee has completed the process for approving the writing of a letter of endorsement for a CFWC or GFWC position, if an addition person(s) make a request for a letter of endorsement at an Executive Board meeting, all potential members to be endorsed will have the opportunity to give a 2 minute speech prior to any vote being taken by the Board to approve the submission of a letter of endorsement on behalf of the SGVD.

Article XVI – Amendments

**Proposed adding Section 3**: The Bylaws may be amended at the Convention by a two thirds vote of delegates in attendance.

**<u>Rationale:</u>** There is currently no language that defines the vote necessary to approve proposed changes to Bylaws.

**If amended will then read:** The Bylaws may be amended at the Convention by a two thirds vote of delegates in attendance.

**Proposed Change:** Any SGVD member sending a mass an email defined as any email message sent to the entire group or large subset for the purpose of sending general information such as an announcement of an event that does not ask for/need a response and a majority of people being emailing don't know each other to members or a group of members shall be requested to use the BCC option. When a message is sent to a group of members that may require a response the BCC option will NOT be used unless requested by individual member(s). Those who are Bcc'd are expected to not respond since the other party doesn't know they were included or were privy to the conversation. The use of Bcc shall be included as a notice to those receiving the email.

**<u>Rationale:</u>** Several members are concerned about the inclusion of their email address in messages sent to members. They want to protect themselves against receiving unnecessary replies, viruses and spam. They would like all emailed communication from the District to use the Bcc format. Others are concerned that using the Bcc option is a sneaky or underhanded way to create a paper trail and is a violation of trust. They want to be sure that their replies to any message are only sent to people whose names are listed as recipients to the message. A Standing Rules needs to balance the concerns members.

**If Amended would Read:** 2. Any SGVD member sending *a mass* email *defined as* **any email message sent to the entire group or large subset** for the purpose of sending general information such as an announcement of an event that does not ask for/need a response and a majority of people being emailing don't know each other, shall be requested to use the Bcc option. When a message is sent to a group of members that may require a response the Bcc option will NOT be used unless requested by individual member(s). <u>Those who are Bcc'd are expected to not respond since the other party doesn't know they were included or were privy to the conversation</u>. The use of Bcc shall be included as a notice to those receiving the email.

Court Appointed Special Advocates (CASA)

I am not sure if you have heard of CASA which is a Court Appointed Special Advocate and GAL which is a Guardian Ad Litem. They are volunteers who advocate for the best interests of children who have experienced abuse or neglect. Most of the children you work with are in foster care. Volunteers work with child welfare professionals, educators and service providers to ensure that judges have the information they need to make the most well-informed decisions for each child. As a CASA advocate you stay with each case until it is closed and the child is in a safe, permanent home. This is a great cause which not only gives a child someone to trust but it is also can be rewarding to those involved. I know there are a few members in the San Gabriel

Valley District who have been CASA Advocates and some of you who are still active today in CASA. I commend you for the work you do and the time you put in. CASA needs more volunteers. If you are interested, I encourage you to contact one of the offices below for your county. They can walk you through the process, which includes, an application, pre-training interview, virtual or in person training, and background clearance. You can also go on line and search on CASA Court Appointed Special Advocate and learn more about what they do and how to get involved. I have fostered children in the past and I know how important it is for a child to have a voice and talk to someone who is not involved in the case. You definitely can make a difference in a child's life.



#### Writing Women Back Into History

"Columbia University will be led by a woman for the first time in its 268-year history", according to cnbc.com. Since 1754, Columbia University has had a male president — but that's about to change. The university announced Wednesday that Nemat (Minouche) Shafik, a leading economist and author, will soon become its 20th president and first woman leader.

The University Board described her as ...." a leader that believes in combining our distinctive intellectual capacities with groups and organizations beyond the academy." She was born in Egypt but relocated to the U.S. after she and her parents lost everything in a "political upheaval." At the age of 36, she was youngest-ever vice president of the World Bank in the 1990's. She also taught at Georgetown University and the Wharton Business School.

Also according to the article, "As president, Shafik will have the responsibility of upholding the university's commitment to diversity, equity, inclusion; Columbia boasts having the first African American advocacy group on a multi-racial campus in the U.S., the first gay-rights advocacy group on any college campus, and the fourth largest international student population of any U.S. university. Columbia joins universities like Harvard, Dartmouth, and George Washington University, which have all elected their first woman president to start later this year,"

*Kim Plater comment: We should all be proud Nemat Shafik's accomplishments; however, if universities are going to boast about having the first "this" or first "that" they should be ashamed that it took 268 years to achieve equality.* 

The University also lays claim to their "first" Advocacy Groups (African American, gay, and a multi-racial campus). Upon checking there have been 20 University Presidents at Columbia (this figure is also questionable). Upon viewing the presidential photos, it does not appear there is any evidence of other than white males. As to the sexual orientation of the presidents, that is not known. This is a reminder that women have come a long way, but they have so much farther to go. Let's help women like Nemat (Minouche) Shafik continue to write women back into history. Universities and colleges should not be touted for hiring a woman. Not once, in the several articles I read, did anyone say, "What took you so long?".
