The Leadership Progression is usually as follows:

LEADS – Training created by GFWC toe encourage and develop new leaders in our Clubs

Chairman- to lead groups established to conduct programs established by GFWC and recommended by the President and ratified by executive committee.

Corresponding Secretary – conduct the correspondence as directed by the president. It may include; collection and compilation of yearbooks, collection, preparation and distribution of correspondence. (appointed).

Secretary – keep the minutes of meetings, distribute as required.

Treasurer – responsible all money deposited in the bank, pay bills, provide a report to all members and maintain records files and documents

Vice Presidents – develop and execute plans of work for the group (Dean of Chairs, Membership Chair, Convention Chair).

Parliamentarian – advise the President regarding parliamentary procedures. Must have knowledge and experience of parliamentary law and have the ability to interpret Roberts Rules of Order, current edition.

President – preside at meetings and have the power to direct, represent and lead all activities of the organization for which they were elected.

The leadership role of a District Chairperson is two-fold. One aspect of the duties of a Chair is to become a knowledgeable resource in order to be able to support Club Chairs. One way to do become the resource is to seek out from many sources great ideas to share with Club leaders on the many projects that can be done. This information can be gathered from reading the club project reports that are submitted, talking with club leaders, attending conferences and workshops and reading Federation publications. The ideas can be shared with others through articles in the Key, presentations at Club meetings, presentations at District meetings, and meetings with Club Chairpersons.

Some Club Chairs are new to their position. They may have new great ideas, they may have been on a committee and now find themselves to be a newly appointed chair. Some are experts in their field. This is where a District Chair has a new leadership role. Group meetings with Club Chairs several times a year provides a venue where experiences and ideas can be shared. Club project chairs can team up with each other to expand and coordinate their work. Samples of project reports can be discussed and shared at these meetings. If the District chair is new to leadership and wants to expand their role, building the networking among Clubs is a great way to develop the relationships the District Chair would need should they want to become an officer. Being a District Project Chair is also a great way for members who have been officers in the past and who now want to continue in a smaller leadership role.
